

Rules for using visitukraine.today resource (User Agreement)

User Agreement (hereinafter referred to as Terms, Agreement) of Web site visitukraine.today (hereinafter referred to as Web site, Web Portal)

The use of visitukraine.today information portal by User means that User accepts and undertakes to comply with all following Terms of Conditions of this Agreement.

Web site Administration reserves the right to make changes to Agreement, which come into force upon publication. The text of current version of Agreement is always available at visitukraine.today Web site. Further use of Web site after making such changes means your consent with them.

Key definitions

Web site (Portal) is the set of files placed in the internet, united by address space of domain www.visitukraine.today.

Web site User (User) is any person who carries out communication / action on Web site hereby automatically confirming full consent to provisions of User Agreement.

Web site Administration (Administration) is the Visit Ukraine NGO, which owns all relevant property rights to Web site and administers it.

Content is any main information posted on information resource, including in the form of texts, figures, photos, video, graphic elements including news and other materials.

1. Rights and obligations of Administration and Moderators of Web site

- 1.1. Administration has the right to change the design of Web site and content at any time and without notice.
- 1.2. Administration has the right to send Users by e-mail and other means of communication messages relating to the use of the Web site.
- 1.3. Moderator of Web site, which is appointed by Administration, monitors and takes necessary measures to ensure that content posted on Web site meets the subject matter of Web site. Moderator and Administration of Web site makes every effort to not include careless, inaccurate, offensive, inappropriate or knowingly incomplete information.
- 1.4. Administration of Web site may use personal data of Users to communicate with these Users, for example, to report about changes / updates on Web site services or send important messages and other similar messages relating to products that have been ordered by User and to contact for purposes related to services provided to User / Client, as well as to inform about promotions, discounts and exclusive offers presented on Web site.

4. Agreement on privacy and personal data maintenance

- 4.2. In case of registration on Web site or filling in applications for ordering financial products presented by Insurance companies, personal data may be transferred to the following third parties:
 - Traffic Statistics Systems of Portal visitukraine.today;
 - Banks;
 - Insurance companies listed on Web site;
 - Insurance agents.
- 4.3. Collection, maintenance, use, processing, disclosure of information received by VISIT UKRAINE NGO as a result of visiting its Web sites by visitors and / or filling in registration forms, including personal data of Users, is carried out according to laws of Ukraine.

By agreeing to the rules for using the information portal, the user agrees to voluntarily pay a service fee for the processing of his profile, personal data, as well as their storage and transfer of data exclusively to the persons specified in clause 4.2. of this Agreement in the amount of 8%.
